1. Tax File Number

It is not an offence if you do not quote your Tax File Number, but if you don't, tax on any income earned will be automatically deducted at the highest rate. Your Tax File Number will be automatically applied to future accounts created under your membership number unless you advise Defcredit otherwise.

2. Password

You can choose to add a password to your member records at Defcredit. If you do, this password will then be required as an additional way to verify you whenever you contact Defcredit through one of our branches or through our Contact Centre.

3. Politically Exposed Person (PEP)

Politically exposed people are individuals who are or have been entrusted with prominent public functions in a foreign country. For example Heads of State or Government, senior politicians, senior government judicial/military officials, senior executives of state owned corporations or important political party officials. Business relationships with family members or close associates of PEPs involve reputational risks similar to those with PEPs themselves. The definition is not intended to cover middle ranking or more junior individuals in the foregoing examples.

Verifying your identity

If you are not already a member, Government regulations require us to see original documents from the following list before opening your account.

If it's difficult for you to attend a branch, you can send us certified copies as noted below and post to the address indicated.

Documents required

You should provide sufficient documents from the lists below to verify your full name and either your date of birth and/or residential address.

If your photographic identification does not have your full name and either your date of birth or residential address, you can use an additional non-photographic identification document to fulfil this requirement.

At least one form of photographic identification should be provided.
